### Privacy Notice (How we use suppliers' information)

#### The categories of workforce information that we collect, process, hold and share include:

We process the following categories of your data:

Personal data: Name, email address, company telephone number, company address, bank details, VAT number.

#### Why we collect and use this information

We use this data to:

- Procure good/services
- To allow the trust to pay for these goods/services

#### The lawful basis on which we process this information

We process this information

1. Because it is necessary for the **contracts** we have with suppliers (and as described in Article 6 of the General Data Protection Regulation);
2. Because it is necessary for complying with our **legal obligations** (and as described in Article 6 of the General Data Protection Regulation);
3. Because processing of special category data is necessary for carrying out our **legal obligations** in the field of employment and under social protection law (as described in Article 9 of the General Data Protection Regulation).

#### Collecting this information

We have obtained your personal data from you directly.

#### Storing this information

Your data is stored on our accounting system (Civica Resource Financials) in order to allow us to pay for goods/services provided to the trust.

We will keep your data throughout our customer relationship with your organisation unless you instruct us to erase data sooner.

We keep your personal data for no longer than reasonably necessary which meet our legal requirements. Examples include: in case of any legal claims/complaints; for safeguarding purposes etc.

#### Who we share this information with

Your personal data will be treated as strictly confidential, and will be shared only with employees of Great Academies Education Trust or authorised third party organisations which will only use your data in accordance with the GDPR. The organisations must have provided their privacy notice.

## Requesting access to your personal data
